

Statutory declaration for Rural, Remote and Northern Territory residency

This form can be used to apply for:

- Flinders University rural and remote subquota
- Flinders University Northern Territory subquota
- Charles Darwin University Northern Territory Residency subquotas
- Adelaide University Rural Background Entry pathway

You may supply one statutory declaration to cover all subquotas/pathways for which you are eligible.

Instructions

1. List the addresses that show you meet the requirements of the subquotas/pathways you wish to be considered for – refer to undergraduate course search for more information about eligibility requirements. You must include:
 - Your full residential addresses
 - Dates of residence including the months and year at each address
2. Sign and date the form before a witness either in-person, or remotely through a video link program – see pages 2 and 3 for a list of authorised witnesses. SATAC accepts electronic signatures, please follow [these instructions](#).
 - If your statutory declaration is to be witnessed remotely through a video link program instead of hand or electronically signed, please follow [these instructions](#).
 - The witness must supply all details requested, including their position that allows them to be an authorised witness, for example: *Registered Nurse, Pharmacist, Full Time Teacher, etc.*
 - A stamp that includes the required information is acceptable
3. You can upload your completed statutory declaration to your mySATAC application. Under 'Submission' in the navigation menu, select 'Documents' then 'Upload personal documents'.

If you do not provide all required details your statutory declaration will not be accepted.

Making changes to your form

Any amendments made to the form must be initialled by both the applicant and the same authorised person who witnessed the statutory declaration. Unwitnessed amendments will not be accepted.

 - b. a member of any of the following:
 - i. Chartered Accountants Australia and New Zealand
 - ii. the Association of Taxation and Management Accountants

 - agent of the Australian Postal Corporation who is in charge of an office supplying postal services to the public
 - APS employee engaged on an ongoing basis with 5 or more years of continuous service who is not specified in another item of this Part
 - Australian Consular Officer or Australian Diplomatic Officer (within the meaning of the Consular Fees Act 1955)
 - bailiff
 - bank officer with 5 or more continuous years of service
 - building society officer with 5 or more years of continuous service
 - chief executive officer of a Commonwealth court

- Commissioner for Affidavits
- Commissioner for Declarations
- credit union officer with 5 or more years of continuous service
- employee of a Commonwealth authority engaged on a permanent basis with 5 or more years of continuous service who is not specified in another item in this Part
- employee of the Australian Trade and Investment Commission who is:
 - a. in a country or place outside Australia, and
 - b. authorised under paragraph 3(d) of the Consular Fees Act 1955, and
 - c. exercising his or her function in that place
- employee of the Commonwealth who is:
 - a. in a country or place outside Australia, and
 - b. authorised under paragraph 3(c) of the Consular Fees Act 1955, and
 - c. exercising his or her function in that place
- engineer who is:
 - a. a member of Engineers Australia, other than at the grade of student, or
 - b. a Registered Professional Engineer of Professionals Australia, or
 - c. registered as an engineer under a law of the Commonwealth, a state or territory, or
 - d. registered on the National Engineering Register by Engineers Australia
- finance company officer with 5 or more years of continuous service
- holder of a statutory office not specified in another item in this list
- judge
- Justice of the Peace
- magistrate
- marriage celebrant registered under Subdivision C of Division 1 of Part IV of the Marriage Act 1961
- master of a court
- member of the Australian Defence Force who is:
 - a. an officer, or
 - b. a non-commissioned officer within the meaning of the Defence Force Discipline Act 1982 with 5 or more years of continuous service, or
 - c. a warrant officer within the meaning of that Act
- member of the Australasian Institute of Mining and Metallurgy
- member of the Governance Institute of Australia Ltd
- member of:
 - a. the parliament of the Commonwealth, or
 - b. the parliament of a state; or
 - c. a territory legislature, or
 - d. a local government authority
- minister of religion registered under Subdivision A of Division 1 of Part IV of the Marriage Act 1961
- notary public, including a notary public (however described) exercising functions at a place outside:
 - a. the Commonwealth, and
 - b. the external territories of the Commonwealth
- permanent employee of the Australian Postal Corporation with 5 or more years of continuous service who is employed in an office supplying postal services to the public
- permanent employee of:
 - a. a state or territory, or a state or territory authority, or
 - b. a local government authority with 5 or more years of continuous service, other than such an employee who is specified in another item of this Part
- person before whom a statutory declaration may be made under the law of the state or territory in which the declaration is made
- police officer
- registrar, or deputy registrar, of a court
- senior executive employee of a Commonwealth authority
- senior executive employee of a state or territory
- SES employee of the Commonwealth
